Important Information:

- All new accounts will be charged a \$100.00 connection fee.
- Billing for Water, Sewer and Garbage is done monthly and is due the 10th of every month. Accounts not paid by the 10th of every month will be subject to a late fee of 10% of the total past due balance. Payments can be made at:
 - Farwell-Kensington Sanitary District office located at 19 Central Avenue North, Kensington
 - Kensington Bank, or
 - By mail to Farwell-Kensington Sanitary District, PO Box 70, Kensington, MN 56343.
- Kensington residents: your water is metered and will be charged a \$35.00 flat rate plus \$5.75 per thousand gallons of water used along with a \$ 5.00 monthly water tower surcharge fee.
- Farwell residents: you do not have city water.
- For residents of Kensington and Farwell sewer is charged based on family size. It is your responsibility to report any changes in household size immediately to Jennifer Kangas at 320-965-2500.
- A garbage container is provided to you and is charcoal grey in color. Garbage pickup is every Tuesday at approximately 7:00 a.m.
- A recycling container is also provided to you and is navy blue with tan lid. No sorting is required; it all goes together in the same container. A list of approved items can be found attached to the top of the lid. Recycling pickup is in the early a.m. of the 2nd Wednesday of every month.
- Additional garbage tags can be purchased at the Farwell Kensington Sanitary District office for \$3.00.
- Disconnection Fee is \$25.00 – Reconnection Fee is \$25.00, the homeowner needs to be present when water service is reconnected. Homeowners must be present at the time of reconnect.
